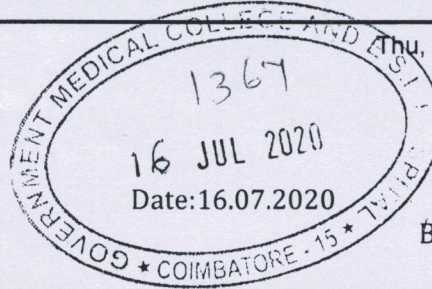

I am directed to convey the approval of Board of Governors in supersession of Medical Council of India for renewal of permission for admission of 5<sup>th</sup> batch of 100 (one hundred only) MBBS students at Government Medical College & ESIC Hospital, Coimbatore u/s 10A of the IMC Act, 1956 for the academic Year 2020-2021. The Board of Governors has granted approval after consideration of the compliance submitted by the college authorities vide letter dated 10.04.2020 in respect of deficiencies pointed out in the Assessment Report (11<sup>th</sup> & 12<sup>th</sup> February, 2020) along with the summary/observations of the member of the Undergraduate Expert Group appointed by the Board of Governors.

2. The permission is valid for one year and for admitting only one batch of 100 students during the academic year 2020-2021. The next batch of students in MBBS course will be admitted in the college only after permission of Board of Governors in supersession of the MCI for renewal/recognition.

3. The Government Medical Colleges (except those located in Union Territory of J & K) shall contribute 15% of MBBS seats for which the renewal of permission is granted for All India Quota.

4. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under IMC Act & Regulations made there under.

5. Discrepancies, if any, may be immediately brought to the notice of the Board of
